

- Lessons in knowing what flexibilities exist and why your state agency doesn't employ them
- The only federal requirements: Income guidelines for receipt of commodities -Standards for applicants to show proof of income -Ensure applicant resides in state (without respect to length of residency)
- Federal regulations allow for, but do not require, a recipient of TEFAP to sign when applying for TEFAP and when picking up TEFAP foods.



- Baby steps:
 - Flexibility during COVID for safety and to accommodate drive-through
 - Household eligibility = Categorical or COVID-19; Signature = COVID-19


