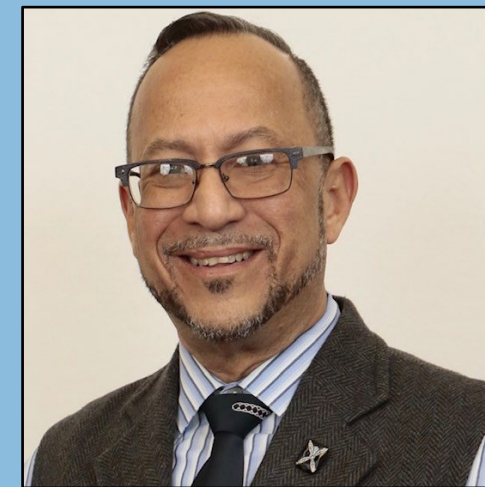

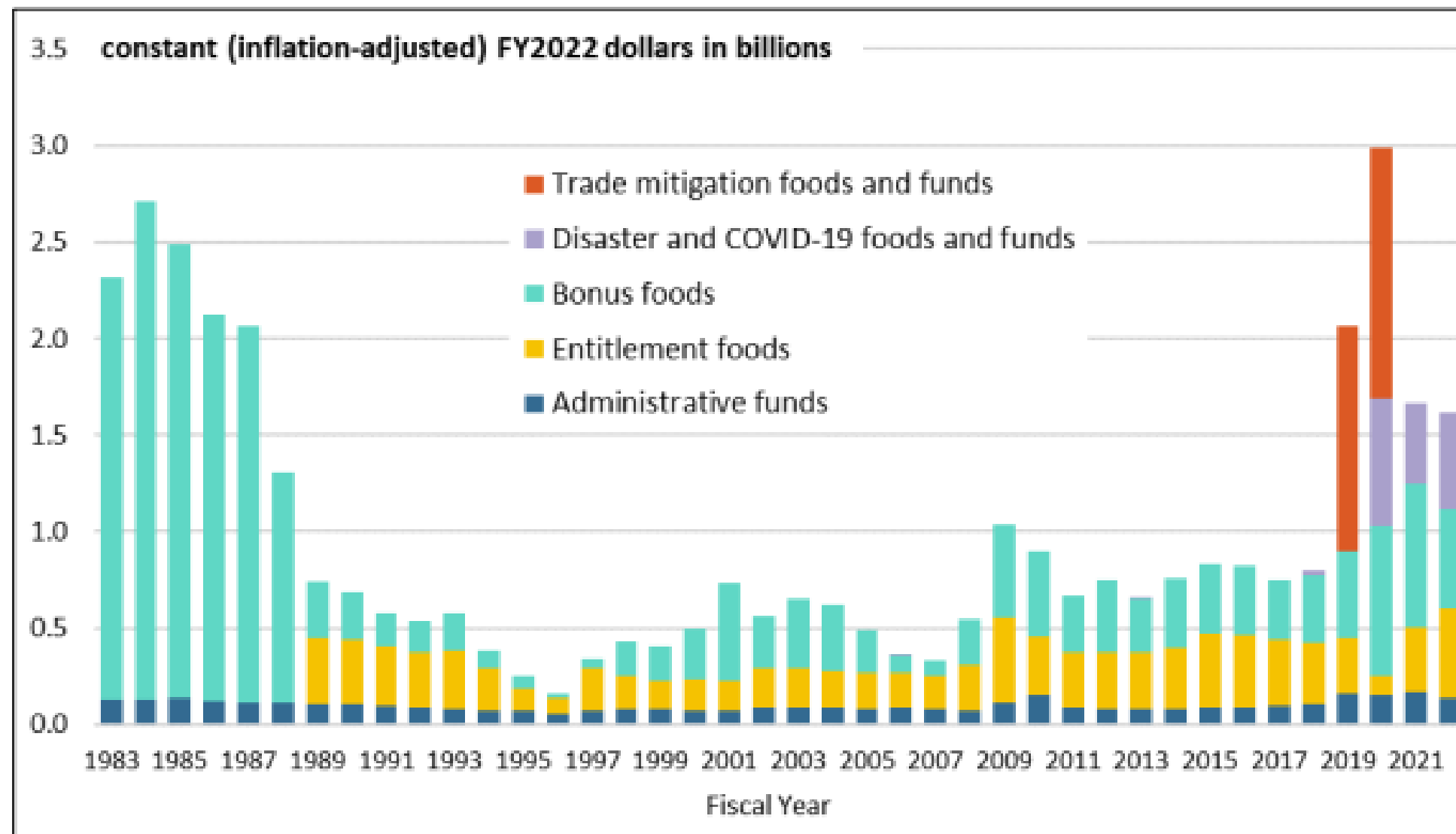

## TEFAP Funding, FY 1983 – FY 2022

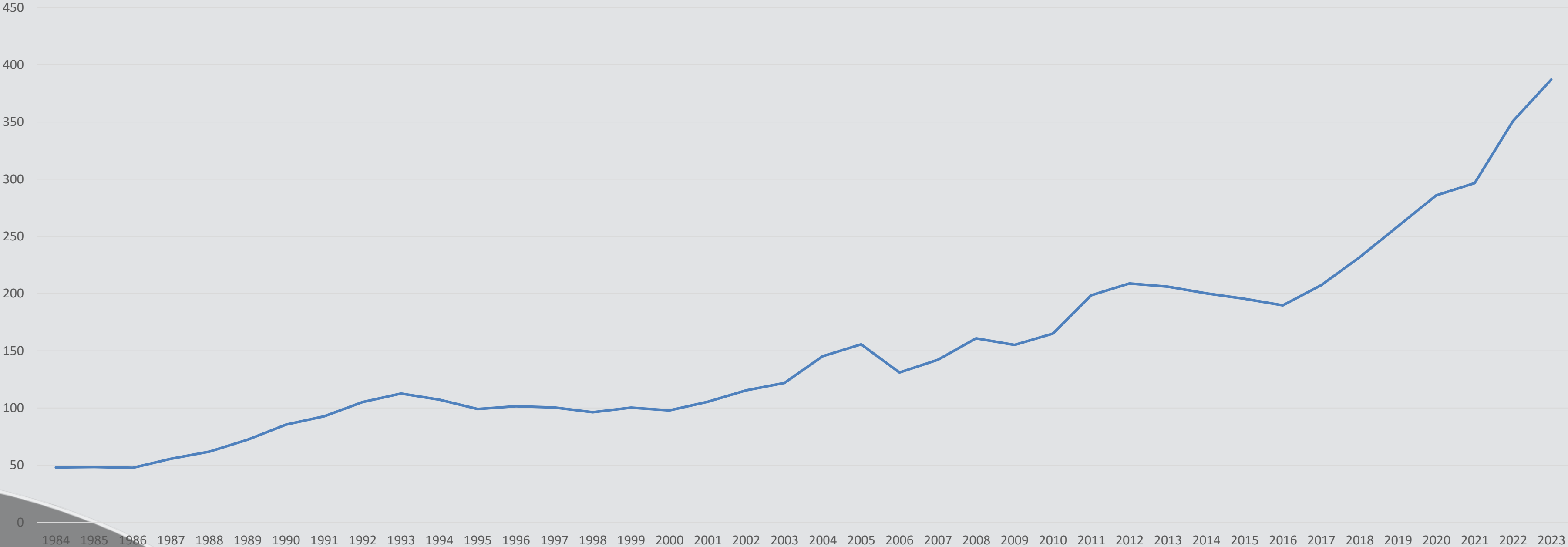

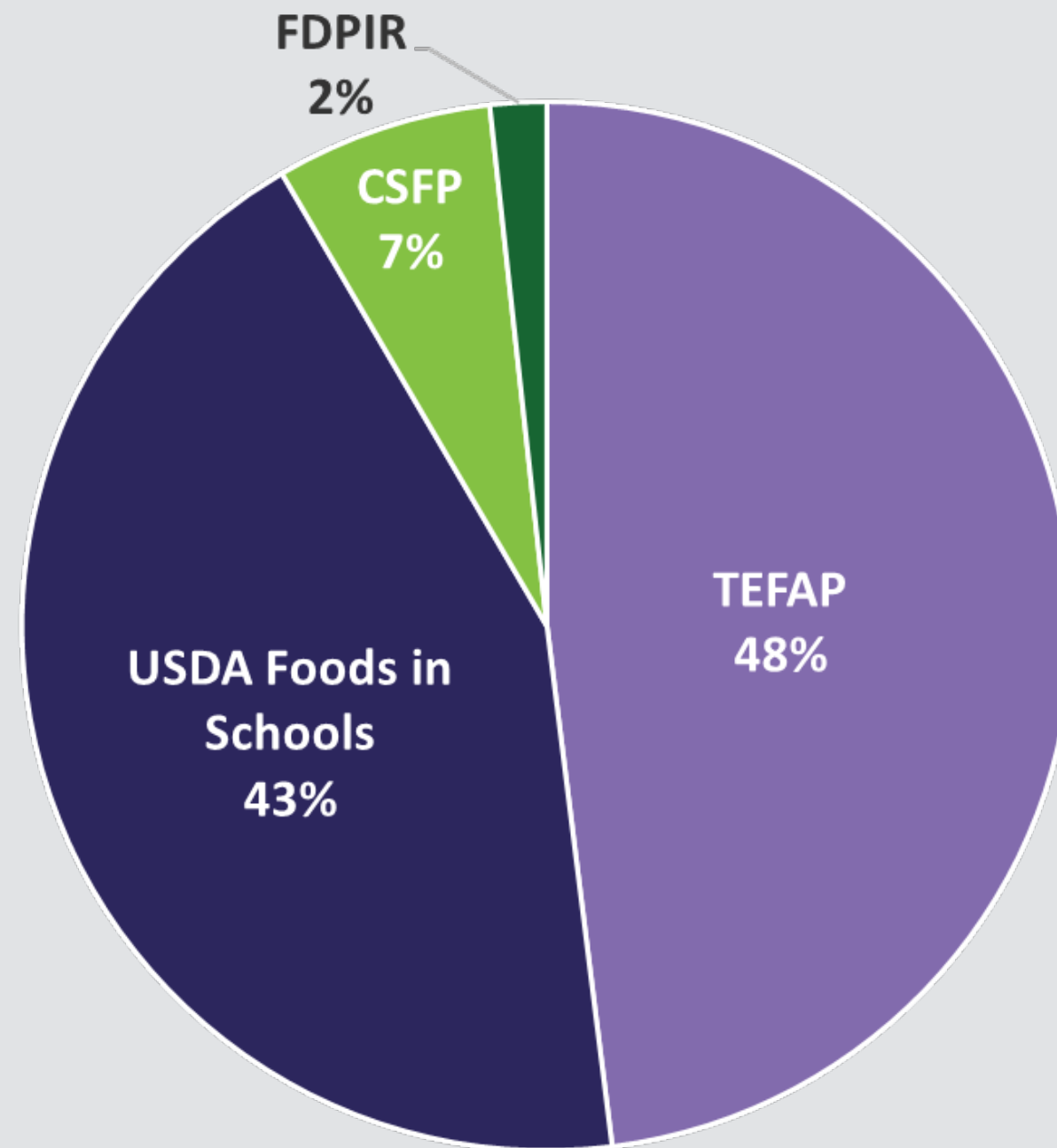

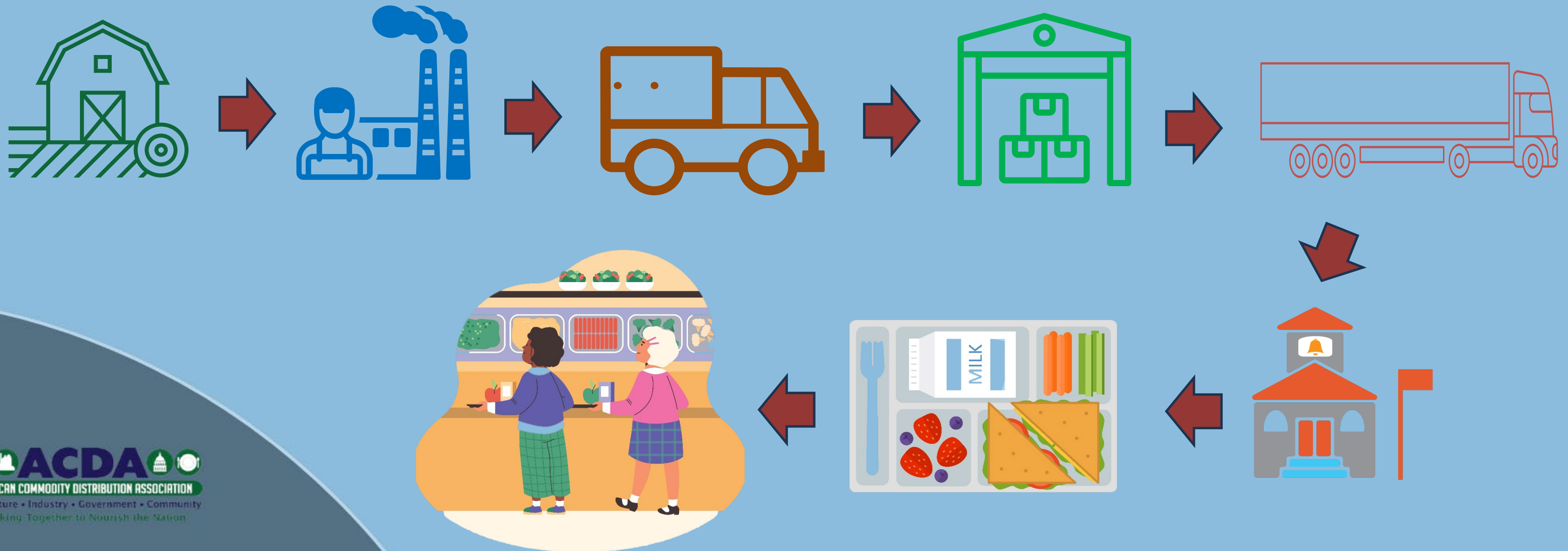
