


Processor Inventory – What Happened 10 Years Ago?


Annual Inventory Reconciliation Process - California

California's Sweep Policy – Effective July 1, 2012

—October 31 is the deadline for SFAs to use their carryover inventory from the prior year's diversions

June 30 _ July through _ Unused Carryover Balance balance October usage to be swept

- -Considerations are made for issues outside of the SFA's control
- —Swept pounds are available to all Recipient Agencies (RAs) on a first come, first served basis in a California Excess Account.



Temporary Sweeps Process Modifications

• In response to RA feedback, the sweeps calculation was modified:

• This sweeps calculation modification persisted through SY 2021-22



Sweeps Communications

- Communications start in Spring
 - Monitor balances and place orders

- Notification via multiple methods
 - Monthly Nutrition Services Townhall
 - OBroad e-mail / Listserv
 - ODirect e-mail from FDP Order Coordinators
 - OAnnual Food Service Director training
 - OState Updates at meetings and conferences




Benefits of a Sweep Policy

- Causes ordering party to consider true needs before placing orders for bulk USDA Foods
- Helps to move and reduce stagnate inventory at the processor
- Helps with six month on hand compliance
- Excess pounds available for all SFAs
 - Justifications define actual needs



Challenges and Changes

- Challenges
 - Timeliness of reporting by the processor
 - Inaccurate figures and calculations
 - Calculation adjustments for case-by-case circumstances
- Changes
 - No changes planned at this time
- Focus is on education for better forecasting, planning and ordering



Annual Inventory Sweep Process - Texas

Sweeps Policy

- 10 years ago Texas swept 85% of excess pounds in November of the subsequent school year.
- Current policy sweeps 100% of excess pounds on July 1st to offset subsequent school year requests.
 - Mid-year usage analysis

What's been resolved?


- Improved oversight and management of processing with all stakeholders.
- Better forecasting at the state level.
- Increased accountability for RAs.

What problems still exist, if any?

We are still having to implement this process every year.




Processor Inventory – It's all about the LIABILITY




Policy Memo FD-064 (revised)

"The SDA may also reallocate the SFA's current USDA Food inventory at a processor to another SFA that may utilize the USDA Foods more efficiently."






